





SUMMARY OF PRELIMINARY & UNAUDITED PERFORMANCE PER STRATEGIC OBJECTIVE & DIRECTORATE OF INDICATORS FOR THE 3RD QUARTER ENDING 31 MARCH 2021.

The graphs above depict the preliminary and unaudited Top-layer SDBIP for the 3rd quarter (1 January 2021 to 31 March 2021), which measures the municipality's overall performance per strategic objective and directorate. On the premise of the preliminary and unaudited status, it is imperative that Council note that the performance reflected is subject to change based on a comprehensive assessment and audit of the actual performance outcomes achieved. The final performance results will be encapsulated in the 2020/2021 Annual Performance Report (as per section 46 (1)(b) of the Municipal Systems Act) and will furthermore be incorporated in the 2020/2021 Annual Report (as per section 46 (2) of the Municipal Systems Act).

In addition, the attached report (2020/2021 Quarter 3 - Top Layer KPI Report) provide insights into each of the 41 TL KPI's and the performance status thereof. Specific emphasis is placed on the 12 TL KPI's that were due within quarter 3.
