1. Purpose

To provide Council an opportunity to consider and adopt the proposed amendment of section "5.2(a): Review of Spatial Development Framework" encapsulated within the 2019/2020 Second Reviewed IDP, in order to align the recently reviewed Spatial Development Framework (SDF) (approved by Council on the 13th of June 2019 - Resolution: C36/2019) with the IDP.

To obtain Council's endorsement for the compilation and publication of the "Amendment of the 2019/20 Reviewed IDP" to the public and relevant stakeholders (which will contain and encapsulate the amended section (5.2 a), as the only change).

2. Background

In July 2019, Council was informed of the intention to amend the 2019/2020 Second Reviewed IDP in order to encapsulate the recently reviewed SDF as a core component within the IDP. Council endorsed (as per Resolution: C58/2019) that an amendment process be initiated in terms of Section 34 of the Municipal Systems Act, read together with Regulation 3 of the Municipal Planning and Performance Management Regulations.

On this premise, the administration proceeded to consult the Cape Winelands District Municipality on the matter, and issued a public notice calling for comments on the proposed amendment. A period of 21 days were granted for public/stakeholder comment, the closing date for submissions being on the 15th of August 2019. Council should note that the deadline has since lapsed, and that no comments and/or inputs were received.

Annexure A depicts the extract of section 5.2 (a) to be incorporated in the "Amendment of the 2019/20 Reviewed IDP".
