**ADDENDUM No 1: TENDER: BV1034/2023: REPAIRS AND MAINTENANCE OF MEDIUM VOLTAGE (MV) SWITCHGEAR FOR A PERIOD ENDING 30 JUNE 2026**

Based on the discussions in the compulsory clarification meeting that was held on Wednesday, 8 August 2023 at 14:00, this addendum is issued to enhance and clarify the technical specifications that have been laid down in the tender document and is not intended to change the specifications materially.

**The following items are being amended, added, removed, or clarified:**

1. Amendments in terms of Part C3.2 Specifications PB, removed categories C, D & E not forming part of this tender. Replace page C3.2.12 with the revise page C3.2.12 (a).
2. Amendments in terms of Part C3.3 Specifications PB, removed commissioning and added the supply and install of the retrofitted breaker. Replace pages C3.3.2 and C3.3.3 with the revise pages C3.3.2 (a) and C3.3.3 (a) respectively.
3. Amendments in terms of Part C2.2 Bill of Quantities, removed commissioning and added the supply and install of the retrofitted type breakers. Replace pages C2.2.2, C2.2.3 & C2.2.4 with the revise pages C2.2.2 (a), C2.2.3 (a) & C2.2.4 (a) respectively.
4. Amendments in terms of Part C2.2 Bill of Quantities, added line item for infra-red scanning and reporting. Replace page C2.2.10 with the revise page C2.2.10 (a).
5. Amendments in terms of Part C2.2 Bill of Quantities, remove commissioning. Replace page C2.2.12 with the revise page C2.2.12 (a).
6. Amendments in terms of Part C2.2 Bill of Quantities, added line item for infra-red scanning and reporting. Replace page C2.2.22 with the revise page C2.2.22 (a).
7. Amendments in terms of Appendix B - Health & Safety Specifications, updated contract period. Replace page B1.5 with the revise page B1.5 (a).

The rest of the ToR (technical specification) remains unchanged.
