THE FOLLOWING QUESTIONS WERE RECEIVED FROM TENDERERS:

1. Typical drawing for v-drain:
We will issue specific drawings where it is deemed necessary once on site. This item is measured in m³ concrete.
2. Header row on all edges laid on 25MPa concrete. Is this the same Type S-A pavers.
The header row is of Type S-C Class 25MPa with thickness 60mm.
3. Joint Venture – Permission from Client.
Permission not required, however take note of Tender Data: Sub Clause F2.1.1
4. Item 13.1.2 Describes the pavers as Red Oxide colour, where as PS MJ 3.1.2 describes Grey colour
The Schedule of Quantities is correct, it should Red Oxide
5. Item: 1.3.5e) Cost of Labourer's Medical is a Prov Sum but there is no allowance for percentage mark-up
Please include Markup under 1.3.5 a) OHS Measures
6. Item 2.1.2 Take down existing fences, store and re-erect afterwards with the same material. What type of fence
This is a /km rate and all relevant fences are included. The contractor may verify what type it is on site if he chooses.
7. Item 10.14.1 states "Extra over item B11"
This should read: "Extra over item 10.13.1
8. Item 14.1.1 c) 300mm wide x 150mm thick 30MPa edge beam but the drawing indicates 300x200mm
Order of precedence of documents: Bill of Quantities take precedence.
9. Are there drawings for services
The survey data does not show all positions and depths of all services. Detail will be discussed on site.
10. Who is responsible to make arrangements with property owners' where fences are clearly constructed within the road reserve
The contractor with the assistance of the local authority structures.
11. Can the contractor's camp be located 'off site'
