5. Once payment has been made (either manually or electronically), please bring completed form and proof of payment to the Fire Department (1 Mercer Street, Worcester), or you may telephonically contact the Fire Safety Inspectorate to make a booking.

6. Inspections will only be scheduled upon receipt of necessary paperwork and proof of payment. Inspections are usually scheduled within 7 days from date of receipt of application
