The Breede Valley Municipality hereby gives notice in terms of Section 116 (3) of the Local Government: Municipal Finance Management Act (No. 56 of 2003), as amended, of its intention to amend the contractual appointment of C. De La Rosa T/A De La Rosa Trailers, under contract reference BV 1078/2024 for the provision cleaning, collection, transportation and disposal of 3m<sup>3</sup> skips (containers) within the Breede Valley Municipal area for a period ending 30 June 2027.

The contract shall be amended to expand the existing scope and services under the same contract terms and conditions.
