According to Section 52(d) of the MFMA, the Mayor must, within 30 days of the end of each quarter, submit a report to the Council on the implementation of the budget and the financial state of affairs of the Municipality.

Effective in-year reporting provides municipal management with an opportunity to analyse performance and address shortcomings and improve internal controls and service delivery. The purpose of this report is to assess the **pre-liminary & unaudited performance** (as per the applicable legislative prescripts mentioned) as measured against the predetermined objectives and key performance indicators (as per the approved 2024/2025 SDBIP).

OVERALL PRELIMINARY & UNAUDITED PERFORMANCE OF INDICATORS FOR THE 4TH QUARTER - 1 APRIL 2025 – 30 JUNE 2025

(1) The graphs below (subsections A and B respectively), depicts the pre-liminary & unaudited performance achieved as at 30 June 2025 (quarter 4) in relation to the 58 TL KPI's that have been formulated and approved for implementation within the 2024/2025 financial year. The performance results are therefore represented as a percentage of the total number of KPI's measured within 2024/2025. 

SUMMARY OF PRELIMINARY & UNAUDITED PERFORMANCE PER STRATEGIC OBJECTIVE & DIRECTORATE OF INDICATORS FOR THE 4^{TH} QUARTER ENDING 30 JUNE 2025.

The graphs above depict the preliminary and unaudited Top-layer SDBIP for the 4th quarter (1 April 2025 to 30 June 2025), which measures the municipality's overall performance per strategic objective and directorate. On the premise of the preliminary and unaudited status, it is imperative that Council note that the performance reflected is subject to change based on a comprehensive assessment and audit of the actual performance outcomes achieved. The final performance results will be encapsulated in the 2024/2025 Annual Performance Report (as per section 46 (1)(b) of the Municipal Systems Act) and will furthermore be incorporated in the 2024/2025 Annual Report (as per section 46 (2) of the Municipal Systems Act).
