

BID NOTICE

SUPPLY OF FUEL TO MUNICIPAL VEHICLES (FLEET) ON A 30 DAY ACCOUNT FOR A PERIOD ENDING 30 JUNE 2019

The Breede Valley Municipality which comprises of four towns (Worcester, Rawsonville, De Doorns and Touwsrivier), is currently utilising the services of Transit Solutions (Pty) Ltd for the supply of fuel to municipal vehicles at local service stations in accordance with the National Treasury's approved tender (RT46). The current contract expires 31 March 2019 and does not cover all vehicles (ie: rented vehicles and other fleet not fitted with e-fuel devices).

Interested fuel stations (outlets), operating within the boundaries of the municipality and who are willing to supply fuel on a 30 day account, are invited to participate in this bidding process in order to supply fuel to those vehicles not covered by the approved National Treasury "RT46" tender.
