Die raad het met onsteltenis kennis geneem van die erge brand wat die naweek van 7 Desember 2019 op die vaste-afval stortingsterrein in Worcester geheers het.

Die gesondheid van ons inwoners is van kardinale belang en besef ek dat die brand veral bejaardes, kinders en persone met swak gesondheid, nadelig kon beïnvloed.

Die kwessie is deur die wyksraadslid tydens die raadsvergadering op 9 Desember 2019 ter tafel gelê met die oog daarop om voorkomende maatreëls in plek te stel en ook om vas te stel hoe die brande veroorsaak is. Daar is ook besluit om storting op die terrein voorlopig te staak.

Daar sal intussen met die provinsiale gesondheidsdepartement geskakel word om te bepaal in welke mate mediese ondersteuning moontlik aan geaffekteerde inwoners gebied kan word.

Die Breedevallei Munisipaliteit bied sy oprechte verskoning aan vir enige ongerief wat inwoners weens die brande ervaar het en wil die versekering gee dat alles moontlik gedoen sal word om 'n herhaling hiervan te voorkom.

Council acknowledged with sadness the incidents of the severe fire that ensued on the weekend of 7 December 2019 at the solid-waste landfill in Worcester.

The health of our residents is of paramount importance and I realise that the fire especially affected the lives of the elderly, children and people with poor health. The issue was presented by the ward councillor during the Council meeting on 9 December 2019 with a view to put preventative measures in place and also to determine how the fires were caused. It was also decided that dumping on the site be discontinued.

In the meantime, the provincial health department will be liaised with to determine to what extent can medical support be offered to the affected residents.

The Breede Valley Municipality would like to offer its sincere apology for any inconvenience that residents have experienced due to the fires and wants to give the assurance that everything possible will be done to prevent a repetition of this.
