- **Event start:** 15h00.
- **Break-down:** Immediately after the event concludes.
- **Clean-up:** The area around your stall must be cleaned before departure.
- Vendors may only sell products specified in their application form.
- Stalls using gas must have:
 - A fire extinguisher on hand.
 - A 'No Smoking' sign clearly displayed.
 - Proof of registration and certification by the BVM Fire Department.
- Vendors are responsible for their own electricity supply or generators (if required).
- A fire blanket is mandatory when using oil for cooking.
- A valid Health Certificate is required to trade cooked food.
- No open fires are permitted.
